CONCERTS: CANTUS PIVOTED TO ONLINE CONCERTS WHEN THE PANDEMIC HALTED IN-PERSON PERFORMANCES, AND THE ENSEMBLE ULTIMATELY PERFORMED SIX ALL-NEW ONLINE PROGRAMS IN THE 2020-21 SEASON WHEN SUCH VOCAL PERFORMANCES WERE RELATIVELY RARE. TO PROTECT THE HEALTH OF THE ARTISTS, THE ENSEMBLE WOULD QUARANTINE FOR TWO WEEKS, COMPLETE COVID-19 TESTING, AND THEN REHEARSE AND RECORD TOGETHER IN STRICT ISOLATION. THESE ONLINE CONCERTS WERE OFFERED ON A PAY-WHAT-YOU-CAN MODEL AND ULTIMATELY REACHED MORE THAN 5,900 HOUSEHOLDS ACROSS ALL 50 STATES AND SEVEN FOREIGN COUNTRIES. AS IN PRIOR YEARS, CANTUS CONCERTS ARE BUILT ON A CENTRAL THEME AND OFTEN INCORPORATE SPOKEN WORD.

EDUCATIONAL RESIDENCIES: COMMITMENTS TO DEEPENING THE MUSIC-EDUCATION EXPERIENCE IN THE LIVES OF YOUNG PEOPLE AND FOSTERING A FUTURE FOR ENSEMBLE SINGING ARE INTEGRAL TO CANTUS' MISSION. WHILE THE PANDEMIC TEMPORARILY HALTED THE ENSEMBLE'S AWARD-WINNING HIGH SCHOOL RESIDENCY PROGRAM, CANTUS LED ONLINE MASTER CLASSES WITH HIGH SCHOOL AND COLLEGE STUDENTS FROM MINNESOTA TO TEXAS, ULTIMATELY SERVING APPROXIMATELY 150 YOUNG MUSICIANS. THE ENSEMBLE ALSO RELEASED AN EDUCATIONAL PLAYLIST THAT ADAPTED ITS POPULAR GUIDED PERFORMANCE TO AN ONLINE FORMAT.

MEDIA INITIATIVES: CANTUS REACHED 3 MILLION LISTENERS VIA PUBLIC BROADCASTING, INCLUDING PERFORMANCES BROADCAST ON MINNESOTA PUBLIC RADIO AND DISTRIBUTED BY AMERICAN PUBLIC MEDIA. ADDITIONALLY, THE ENSEMBLE'S POPULAR "COVID-19 SESSIONS" A SERIES OF 19 SONGS RECORDED IN MARCH 2020 IMMEDIATELY PRECEDING MINNESOTA'S STAY-AT-HOME DIRECTIVE DREW THE INTEREST OF BRITISH RECORD LABEL SIGNUM CLASSICS, WHICH RELEASED THE RECORDINGS GLOBALLY ON SUCH DIGITAL PLATFORMS AS SPOTIFY AND APPLE MUSIC. FINALLY, CANTUS EXCERPTED SONGS FROM ITS ONLINE CONCERTS TO SHARE FREE OF CHARGE ON SOCIAL MEDIA, THROUGH ITS WEBSITE, AND IN ITS MONTHLY E-NEWSLETTER TO OFFER BROADER ACCESS TO ITS MUSIC.
